

## **PUBLIC MEETING NOTICE (NOTICIA PUBLICA)**

Notice has been given that the Brownsville Metropolitan Planning Organization, (MPO) will receive comments on a proposed amendment of the MPO's F.Y 2016 Unified Planning Work Program (UPWP), as follows:

The BMetro Strategic Transit Plan will be conducted by a firm overseen by the MPO, instead of BMetro, over two fiscal years. The MPO will use a combination of PL (federal funds) and a local share instead of using Category 7 funds. Below, please find a proposed outline for transfer of funds to make this possible:

Current Funding: \$98,630.75; Adjustment/Transfer: \$8,500.00;  
Balance: \$90,130.75
- Subtask 1.3 MPO Public Participation & Involvement  
Current Funding: \$98,432.15; Adjustment/Transfer: \$58,000.00;  
Balance: \$40,432.15
- Subtask 1.5 Safety & Security in the Transportation Planning Process  
Current Funding: \$8,360.00; Adjustment/Transfer: \$2,500.00  
Balance: \$5860.00
- Subtask 4.2 MPO Thoroughfare Plan  
Current Funding: \$15,000.00; Adjustment/Transfer: \$12,000.00;  
Balance: \$3,000.00
- Subtask 5.1 Congestion Management Process Planning (CMPP) and Data Collection  
Current Funding: \$50,100.00; Adjustment/Transfer: \$40,000.00;  
Balance: \$10,100.00

Proposed (PL) funding: Subtask 5.3 \$121,000.00, plus additional carryover PL funds in the amount of \$12,306.36 and local funds in the amount of \$26,656.14 to total \$159,962.50.

Accordingly, the BMetro Strategic Transit Plan is proposed to be removed from the Transportation Improvement Program (TIP) listings.

Action on these matters is scheduled to be considered by the MPO Policy Committee on Wednesday, February 10, 2016 at 10 a.m. at the City Hall Commission Chambers, 2<sup>nd</sup> Floor, 1001 E. Elizabeth St., Brownsville, TX 78520.
